The Boat Guys, Inc. carries adequate liability and worker compensation insurance and will furnish proof of insurance upon request to either the Customer and/or to the marina, boat yard, or other facility where the work on the boat is to be performed. It is the responsibility of the Customer to clear with such marina, boat yard, or other facility prior to The Boat Guys, Inc. arriving to perform services. It is the policy of The Boat Guys, Inc. that we do not share our contract information with third parties, including a marina, boat yard, or other facility unless granted permission by the Customer. The Boat Guys, Inc. does not submit invoices to third parties nor do we pay out of pocket to be allowed to work on the vessel of the Customer at any marina, boat yard, or other facility. The Customer should be advised that he/she has the legal right to hire The Boat Guys, Inc. or other service provider of his/her choice without interference from the marina, boat yard, or other facility at which the services are to be performed. The Service Provider will furnish a copy of the Rhode Island Attorney General advisory opinion 87-12-01/87-21-04 to the Customer or marina, boat yard, or other facility upon request. The Boat Guys, Inc. shall be held harmless by the Customer and/or third parties from all claims arising from any loss or damage to any boat hardware, parts, carpets, clear vinyl or acrylic enclosures, vinyl seats, canvas enclosures, zippers, snaps, canvas tops, brackets, mounting hardware, rails, swim platforms, or other component of the vessel the integrity of which part may have been compromised by prior normal wear or due to a want of proper preventative maintenance (whether direct, indirect, or consequential, except in the event of gross negligence) which may arise from the provision of the Services. All services must be secured with a Visa or MasterCard number and no charges will be processed until services have been completed. Payment is due upon completion of services and if the Customer wishes to pay by check it must be received on or before service date.
